


MARY & EDWARD

For over three decades, McGees Property has played a pivotal role in the journey of 93 Edward Street, one of Brisbane's most historically significant buildings. Our involvement began in 1990, managing the asset on behalf of new owners who acquired it for \$2.3 million from the Kytherian Association. At the time, the building was already 80 years old, strategically positioned on the corner of Edward and Mary Streets, making it a valuable investment.

Now in our 35th year of managing the property, we have navigated significant milestones, including heritage listing, transfer of development rights, and securing 9B classification for education use. When the original ownership group chose to realise their investment, McGees Property facilitated the sale and was subsequently reappointed by the new owner, marking the next chapter of its evolution.

As the surrounding precinct undergoes transformation with major developments such as The Queen's Wharf Brisbane and Waterfront Brisbane project, 93 Edward Street is positioned to benefit from increased activity and rising demand for premium space in Brisbane's CBD.

History

Built in 1910, 93 Edward Street has stood as a testament to Brisbane's commercial evolution. Originally known as the Youngs Building, it was developed by Horris Edward Brouton Young and Charles Earnest Young, who purchased the site of the Commercial Hotel in 1909 for redevelopment. The result was a striking timber-frame brick warehouse, costing £16,000, rising three stories high with a four-storey corner section.

Over the decades, the building housed a diverse mix of tenants, including tobacco and cigar merchants, corporate offices, and education operators such as language schools. It was also home to Eckersley's, a well-known arts and crafts supply business. In more recent years, the Players Brisbane Club, later known as Universal Lounge, occupied the space, reflecting the evolving nature of the precinct.

Listed on the Queensland Heritage Register on 22 February 1995, the building is recognised for its contribution to the historical fabric of lower Edward Street, exemplifying early 20th-century commercial architecture.







Present

Today, 93 Edward Street represents a distinctive fusion of heritage charm and contemporary functionality. The property is now owned by Pellegrino Group Australia (PGA), following its acquisition from a privately operated investment group.

Managing an asset of this age presents both challenges and opportunities. From maintaining intricate historical features to overseeing modern refurbishments, McGees' role has been integral in preserving the building's legacy while enhancing its usability. Recent developments by the current landlord have included:

- Major refurbishments to lower ground, upper ground, second, and third floors
