FOR PERSONS INSPECTING PROPERTY COVID-19 – Private Property Inspections

- Prior to requesting an in-person property inspection we would ask that you visit our website to first view a 360o virtual tour of the property to be sure you wish to visit the property in person.

- We ask all persons wishing to view properties in person to understand that an occupier of a property may request, at any time, that the Agent refrain from undertaking in-person property inspections and the Agent must adhere to such requests.
- The Agent maintains the ability to cancel or postpone any property inspection at any time, should circumstances surrounding the property or the occupants of the property change insofar as conducting an in-person property inspection may constitute posing further contagion risk to others.
- You must complete the brief questionnaire on the back of this card, sign and date it and provide it to the Agent prior to gaining access to any occupied property. Should you require a copy of your completed questionnaire, please advise the Agent and it can be scanned and forwarded to you via email, or a photocopy of it shall be provided to you.
- You must provide the Agent with proof of identity by way of a photograph form of identity, which will then be copied or photographed by the Agent to be kept on file with your completed questionnaire.
- A maximum of two (2) persons only (being the Agent + 1 other person) shall be given access to an occupied home for a property inspection.
- All persons undertaking a property inspection are asked to refrain from touching their nose, eyes
 or mouth whilst at the property.
- All persons undertaking a property inspection are asked to refrain from touching any surfaces or items whilst at the property.
- All persons present at a property inspection must endeavour to adhere to 1.5m self-distancing at all times.
- In attending an inspection you are required to supply your name, address & contact details. If it
 is later found that you have been exposed to COVID-19 you will be notified immediately. You
 will also be required to agree in writing to contact our office should you later become aware
 you have been exposed to COVID-19 or persons exhibiting symptoms of COVID-19.
- All property occupiers will have been requested to advise the Agent if they have been experiencing fever, sore throat, cough, fatigue or difficulty breathing prior to access to the property being provided to you.
